Cardholder Agreement

The Ascend™ Card from Rockwell Collins Flight Information Solutions (the Card) is issued by and credit is extended by Rockwell Collins Flight Services, 2925 Briarpark Drive, 7th Floor, Houston, Texas 77042.

The holder of the Card represents that the Card will only be used to obtain business or commercial credit.

Usage of the Card by the Cardholder named on it constitutes acceptance of the following terms and conditions, as may be amended from time to time: "Usage...by the Cardholder..." includes the retention or use of the Card by the Cardholder as named on it or by anyone under his/her/its control. The holder of the Card is liable for any unauthorized use of the Card and the holder agrees to be responsible for any unauthorized use.

A credit line will be assigned to your account. This line includes all unpaid purchases, whether billed or unbilled. If, as you use your Card, you find your credit line to be inadequate, please call (800) 987-5662 or (713) 430-7500. Statements will be sent and your payment is due within 28 days of the statement date. Statements outstanding more than 28 days will be considered delinquent. Delinquent accounts will be assessed a late charge at a per billing period rate of 18% per annum/1.5% per month of the amount of the past due invoices, or the maximum amount permitted under the law.

If your bank should fail to honor payment to Rockwell Collins Flight Services or your account becomes delinquent, Rockwell Collins Flight Services may require immediate and full payment of all outstanding amounts, as well as the return of your Ascend™ cards. Rockwell Collins Flight Services neither sells nor warrants the goods or services obtained from the Ascend™ card vendors.

In recognition of the national and international nature of aviation and the necessity for legal certainty, predictability and convenience, this Agreement and all actions and transactions contemplated herein are governed and controlled by the laws of the State of Texas without regard to Texas's conflict or choice of law principles. Rockwell Collins Flight Services may choose to pursue legal action against the Cardholder in any state in which the Cardholder does business or where jurisdiction may otherwise be proper.

In the event the Cardholder fails to make full payment when due, the Cardholder acknowledges and agrees that Rockwell Collins Flight Services may, in addition to all other rights and remedies, invoke any and all statutory or equitable lien rights or those of any participating aviation merchants in connection with the enforcement of Rockwell Collins Flight Services' right to payment under this Agreement and hereby authorizes Rockwell Collins Flight Services to file a lien for the unpaid charges, plus late fees at 18% APR, aircraft title search fees, filing fees, collection costs and attorney fees against any aircraft for which charges were incurred and made to the Cardholder's account. The Cardholder represents and warrants that the Cardholder either owns the aircraft for which goods and services are purchased, or is lawfully possessed of the aircraft with the owner's express consent to purchase goods and services for the aircraft on credit provided by Rockwell Collins Flight Services. The Cardholder agrees to indemnify and hold harmless from and against any and all claims arising out of Rockwell Collins Flight Services' filing or enforcement of a lien against the aircraft. If the debt remains unpaid, Rockwell Collins Flight Services may institute an action against the Cardholder (and/or the aircraft owner) to foreclose the lien and to collect the debt.

In recognition of the international and mobile nature of aviation and aircraft and the necessity for legal certainty, predictability and convenience and to avoid filing liens in multiple jurisdictions, any lien filed by Rockwell Collins Flight Services shall be based, at Rockwell Collins Flight Services' sole discretion, either upon the aircraft lien statute of the State of Texas, Texas Property Code SS 70.301 et al, or the applicable aircraft lien statute of the foreign country in which the aircraft is registered, regardless of where (a) the Cardholder resides or does business, (b) the aircraft owner resides or does business, (c) the aircraft was at the time the charges were incurred, (d) the aircraft is registered, or (e) jurisdiction may otherwise be proper.

The Cardholder will be liable to Rockwell Collins Flight Services for all costs and expenses of lien preparation and filing, collection and litigation including, but not limited to, late charges, attorney fees, court and discovery costs incurred by Rockwell Collins Flight Services in enforcing its rights hereunder. The Cardholder agrees that the venue for enforcement of this Agreement and any lien shall be in the state courts of Harris County, Texas, USA, regardless of diversity issues or the amount owed. By the Cardholder's use of the Ascend™ card account, the Cardholder waives all objections to the foregoing choice of law or forum.

In the event of the Cardholder's breach or default under the terms of this Agreement, the Cardholder will be liable to Rockwell Collins Flight Services for all costs and expenses, including late charges and reasonable attorney's fees or other costs of collection, incurred by Rockwell Collins Flight Services in enforcing its rights hereunder. The Cardholder agrees that in the event of default in payment, Rockwell Collins Flight Services may institute suit against the Cardholder in the aforesaid courts regardless of where the Cardholder is geographically located or does business.

Either you or Rockwell Collins Flight Services may terminate this Agreement at any time. Once the Agreement is terminated, you must return to Rockwell Collins Flight Services all Cards in your possession or control. Payment of all outstanding amounts must be paid upon termination.

If Cards are lost or stolen, it is the Cardholder's responsibility to call Rockwell Collins Flight Services immediately to prevent unauthorized usage. Call (800) 987-5662 or (713) 430-7500 to report lost or stolen Cards. Please follow up with written notification sent directly to Rockwell Collins Flight Services 2925 Briarpark Drive, 7th Floor, Houston, Texas 77042.
